cancelled. Not sure how much this will cost us at this point. If costs are reasonable, the show account may be able to cover losses this year. Final billing from Onofrio has not

been received. Committee is working on next year's show.

Obedience: AKC has suggested guidelines that they put out. Barb and show secretary are reviewing

the guidelines to see how they will affect the trial this fall.

Agility: Have venue, judge, and show secretary. Not submitted paperwork to AKC yet.

Charitable Donation: Nothing to report.

Scholarship Committee: Committee is working on reviewing the applications. There were 5 outside applications

and 1 inside application.

History behind discussion. Idea presented to membership in December to form Dog Care Subsidy Program. Committee presented board with proposal at February 19 Board Meeting, board approved with modification. At April 8 Board Meeting the budget was amended to cut out all donation, and expenses that were not necessary for the club to continue other than the Scholarship Program that was already in progress for the year with another budget review in August. Before the May meeting, the Dog Care Subsidy Program was revised. Document was not ready for presentation at the meeting.

Sandy is working with committee to revise the proposal as a reimbursable grant and will send the draft to the agility committee for further review. Jim has proposed that we call a special meeting to vote on this when the draft is completed and sent to the membership.

Lisa motioned to table further discussion until the membership sees a written proposal,

Nancy seconds, motion passed.

Election Guidelines: There is no record of the club approving the election guidelines that are to be included in

the Standing Rules, therefore Nancy motioned to approve election guidelines, Kathy

seconded, motion passed.

June Meeting: Discussion started about having a meeting in June since there will be no show. According
