passes.

Treasurer Report: Statement: \$4191.58 in Checking Account, \$5 in Share Savings, \$95519.65 in Money Market

with total asset of \$99716.23. Online checking account balance as of today is \$10261.56. Jim was able to confirm balance. Cathy has checks to deposit from Agility Trial and Membership dues. Gloria motions to accept the Treasurer Report as presented, Karen seconds, motion

Committee Reports:

Cluster: All 4 shows approved by AKC. Planning continues. Next meeting is on January 3rd, 2022.

Obedience: Final paperwork from Show Secretary was mailed. Report taking longer as ribbon vendor

didn't come through (she is going out of business) and ribbons were ordered through Onofrio instead. Cindy distributed them in early December. Entries were good, it was embarrassing that we didn't have ribbons. Gloria suggested that the Obedience and Agility Committees

work together to find new ribbon vendor to save fees.

Agility: Entries filled both days, which was a first. There were 330 runs each day. It was a successful

show. Everything went well, although it was tight quarters for crating. Profit will be around

\$2000, final numbers aren't in yet. Financials will be ready for January meeting.

Charitable Donation: Last spring the Board approved \$7000. \$1000 went to Toys For Joy, \$1000 went to MPDBA

Feeding Furry Friends drive, \$1000 went to the Alexandra House, \$1000 went to Soldiers 6 (they take dogs from shelters and train them for PTSD) Soldier 6 received additional \$500 bonus for donating on "Give To The Max Day" through that program, and \$3000 to Anoka County Sheriff's Department Canine Unit. We have committed to a \$3000 donation for the

next 3 years

Scholarship Committee: Scholarship form updated.

Website: Need to go through 400 pictures from Agility Trial and download them to the website.

Sunshine: No report

Education/Programs: Has UnderDog dog beds lined up. Used in orthopedic surgery centers.

Banquet: Greenhaven is booked on January 29, 2022, for our Banquet. Due to Covid, Anita is looking

into getting refund. Discussion ensued to postpone the banquet until July and combine it with the Picnic. Cathy Bosnic motions to postpone Banquet until July, having Karen check with

caterer and the Club covers cost, Lynda Lee seconds, motion passes.

Standings Rules Committee: Board approved Standing Rules and to include amendment from the Dog Subsidy Program.

Cathy motions to accept standing rules as posted, Kathy seconds, motion passes.

Dog Subsidy Program: Amendment was submitted to the Board and approved. The change in the program is that we

can select up to 3 veterinarians (which can reside in or out of Anoka County as long as there is a professional relationship with a club member). Form will be updated. Laurie will connect

with vet for final report and give report at the January Meeting.

Reunite Trailer and police dogs donated.
