Lisa Dankert asked if you can still show your dog's if you are helping with the specialties. Karen responded that if you are not assisting with Judge Selection or have interaction with the judges, you can still show at solstice. There are 2 judges chairs, Karen, and Wayne, at this time. Obedience:	We did lose money on the obedience trial. When we applied in august, the only thing against us was an agility trial. Unfortunately, a FastCAT event and Nose work trial came up after we got approval. We had a discussion regarding going forward and will be moving back to September next year. Do we want to try and do 3 days in September or go back to 2 days. Lots of compliments about our out of state judge, people loved showing to an out of state judge. Agility and rally are AKC Event. Tom Krenn said he would do Sat and Sunday but would not be available for Friday if we do a 4 day show as it is hard to get off work. Gloria will work with Jamie a little more and bring back more information in October.
Agility:	October trial closes a week from today. Numbers are looking decent, and we continue to move forward. Left over Pulled Pork and Pulled Chicken will be served for the October event. October event is Oct 13th (international) 14th and 15th are the agility trial. Being held at On the Run. December trial is at Cloud Nine on the 9th and 10th.
Charitable Donation:	Now that we know the numbers from Solstice, were we going to adjust the amount? Gloria: when we set the budget in Feb, we were going to stick with that number. If they have something that they really are passionate about, we can revisit it. We spend last year's money, not this year's funds. It's okay to have them bring forward something that everyone is passionate about.

She utilized a lot of other club's documents when reviewing and updating our most recent approved 2021 Constitution/Bylaws and Standing rules. It was determined that Lisa and Nancy will review the current regulations with AKC to determine if we can house our Constitution/Bylaws and Standing rules on the public website. Kathy Billman has confirmed that to move them from the Members Only section to a new public section is very easy to do once we know for sure we can do so. The club believes that if we can post them publicly, we should defiantly do so.

## New Business:
